



New Zealand Residence Programme *Fortnightly Selection Statistics – 11 April 2007*

1. Selection 11 April 2007– Skilled Migrant Category

The most recent selection of Expressions of Interest (EOIs) under the Skilled Migrant Category took place on **11 April 2007**.

- **378** EOIs were selected that had a points total of **140** or above;
- **120** EOIs were selected that had a points total of **100** or more but less than 140, and included points for offers of skilled employment or current skilled employment in New Zealand.
- **137** EOIs were selected that had a points total of **100** or more but less than 140, and included 15 points for work experience in an area of absolute skill shortage.
- **54** EOIs were selected that had a points total of **120** or more but less than 140, and included 10 points for work experience in an area of absolute skill shortage.

As a result, **689** EOIs representing **1,528** people were selected and will now undergo preliminary verification to determine if an invitation to apply for residency will be issued.

2. The make-up of selection

Based on the information provided by people who had their EOIs selected, the make-up of the 11 April 2007 selection is as follows:

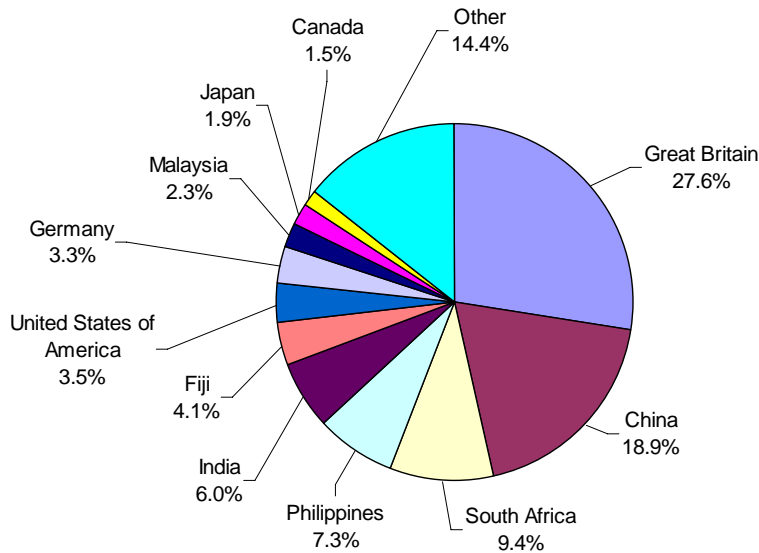

11 April 2007**

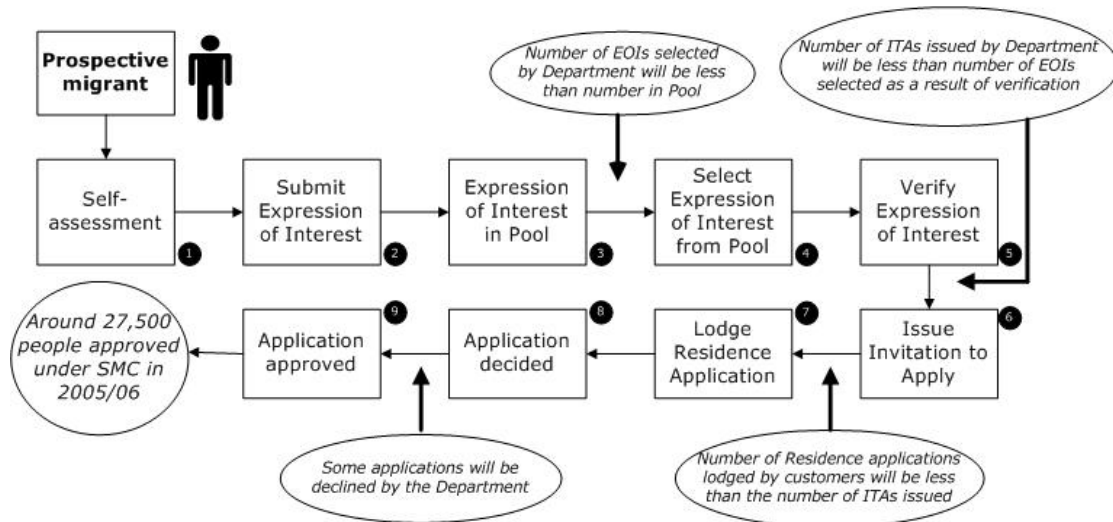


4. Statistics since December 2003
