



New Zealand Residence Programme *Fortnightly Selection Statistics – 22 November 2006*

1. Selection 22 November 2006 – Skilled Migrant Category

The most recent selection of Expressions of Interest (EOIs) under the Skilled Migrant Category took place on **22 November 2006**.

- **468** EOIs were selected that had a points total of **140** or above;
- **122** EOIs were selected that had a points total of **100** or more but less than 140, and included points for offers of skilled employment or current skilled employment in New Zealand.
- **73** EOIs were selected that had a points total of **100** or more but less than 140, and included 15 points for work experience in an area of absolute skill shortage.
- **32** EOIs were selected that had a points total of **100** or more but less than 140, and included 10 points for work experience in an area of absolute skill shortage.

As a result, **695** EOIs representing **1,544** people were selected and will now undergo preliminary verification to determine if an invitation to apply for residency will be issued.

2. The make-up of selection

Based on the information provided by people who had their EOIs selected, the make-up of the 22 November 2006 selection is as follows:

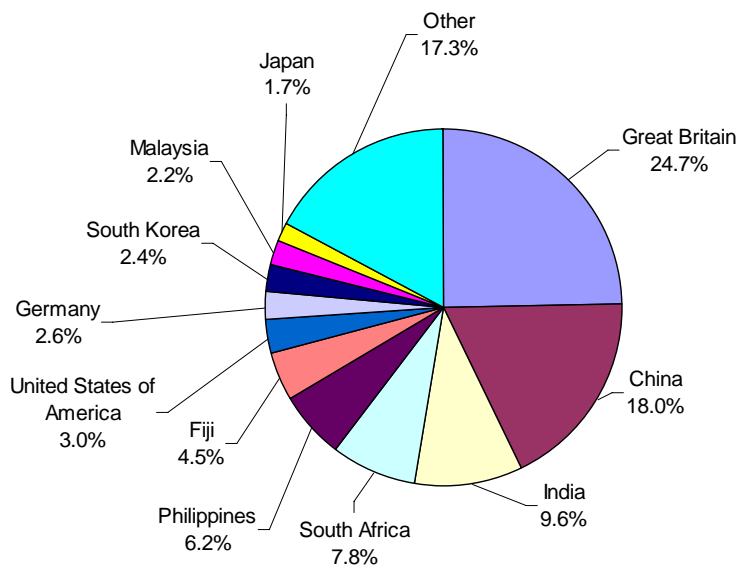

22 November 2006**

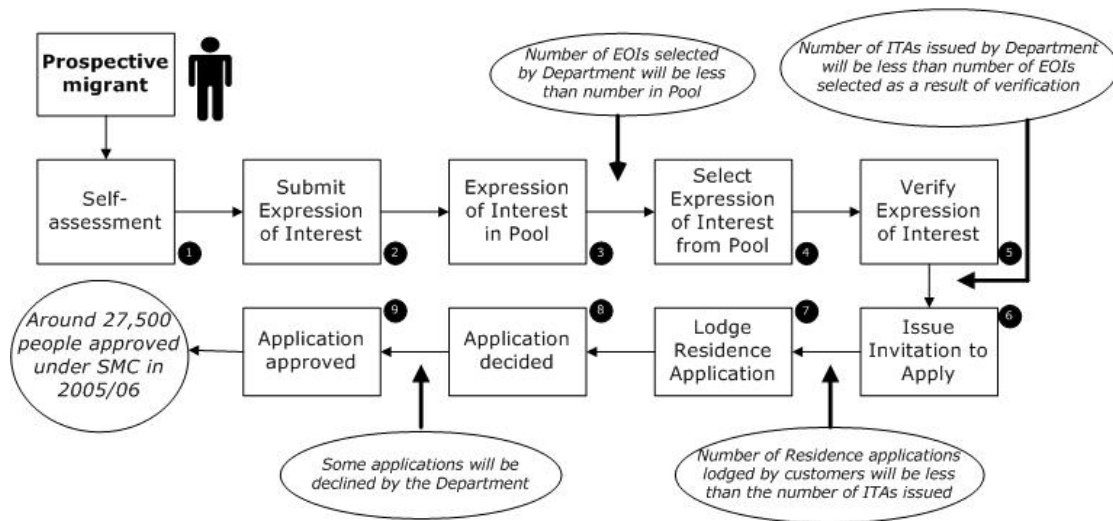


4. Statistics since December 2003

Since the Skilled Migrant Category opened in December 2003, a total of **51,640** EOIs, representing **120,567** people, have been selected.

Approximately **94 percent** of those EOIs selected have been verified (stage five below).
